

**London Britain Township
Board of Supervisors Meeting**

January 5, 2026 approved 1/29/26 BOS mtg

Aileen Parrish, Chairman of the Board of Supervisors, opened the Board of Supervisors Reorganization meeting at 7:00PM. In attendance were Supervisors Brian Sachs and Bruce Yost, Secretary Carolyn Matalon, Supervisor Parks and Open Space Adam Brady and Planning Commission members Les Town, Stephanie Town and Don Morgan, Zoning Officer Dave Gargula, Tax Collector Judy Porta, Land Trust member Mary Beth French and one additional guest.

Board Reorganization

Chairman – Aileen Parrish made a motion to nominate Brian Sachs as the Chairman of the Board of Supervisors. Bruce Yost seconded and the motion carried unanimously.

Vice Chairman - Brian Sachs made a motion to nominate Aileen Parrish as the Vice Chairman of the Board of Supervisors. Bruce Yost seconded and the motion carried unanimously.

Resolution #26-1

Brian Sachs read the Resolution appointing Carolyn Matalon as Secretary, Dana Copare as Assistant Secretary, Nette Stejskal as the Treasurer and Pamela Morgan as Assistant Treasurer for a one-year term, ending at the 2027 Reorganization Meeting. Brian Sachs made a motion to adopt Resolution #26-1 as read. Aileen Parrish seconded, and the motion carried unanimously.

Resolution #26-2

Brian Sachs read the Resolution setting in place the first meetings of the month on the second Monday of February through December, and the first Monday of January. The second meeting of the month will be held on the fourth Monday of January through April and June through November and the third Monday of May and December. London Britain Township will remain a one road district. Real Estate Transfer Taxes shall be set at 1% of value with LBT receiving 0.5% and the rate of pay for all people, except elected Supervisors.

The rate of pay for all people, except elected Supervisors, performing road work in the Township shall be at the discretion of the Roadmaster and the Supervisors responsible for roads and is not to exceed \$15.00 per hour or \$18.00 with a CDL license, except for the Roadmaster and other permanent road employees and all persons and/or companies under contract to the Township to do road work.

The rate of pay for all people, except elected Supervisors, performing parks and open space work in the Township shall be at the discretion of the Supervisor of Parks and Open Space and the Supervisors responsible for parks and open space and is not to exceed \$15.00 per hour except employees and all persons and/or companies under contract to the Township to do park and trails work.

Adjournment

Brian Sachs made a motion to adjourn the Reorganization Meeting at 7:10pm. Aileen Parrish seconded, and the motion carried unanimously.
